The International College of Management, Sydney (ICMS) has partnered with Motti + Smith Events to award an ICMS Event Management student a unique scholarship offering a tuition waiver valued at UP TO \$10,000.00, and a paid internship with Motti + Smith Events. The Motti + Smith Events Scholarship is awarded to a student who displays enthusiasm and motivation for the events industry and whose aptitude, academic results and previous work experience fit with the sponsor's (Motti + Smith Events) business goals.

Applications for the Motti + Smith Events Scholarship are invited from students enrolled in the ICMS Bachelor of Event Management who have completed a minimum level of 2 full-time study periods (8 subjects), successfully completed WIL200, AND have tuition fees remaining in your degree to apply the scholarship credit for this specific scholarship.

Work experience in an area of relevance is preferred. NOTE - the Scholarship Board will determine and confirm eligibility upon receiving application submissions.

The Motti + Smith Events Scholarship is awarded to the student based on the selection process implemented by the ICMS Scholarship Board.

Value:

A tuition waiver valued at **UP TO** \$10,000.00 at current tuition fee levels (applies to domestic or international students) plus an internship at Motti + Smith Events with an amount of \$500 paid each week to the successful candidate during the internship. Motti + Smith Events will cover travel, accommodation and meals around event days. The successful student is required to work full time with Motti + Smith Events during the internship, and this can be counted as part of industry training placement hours. The internship can commence in November 2024.

A key priority of the ICMS Scholarship Program is to create opportunities for as many students as possible, where eligible. In support of this priority, previous recipients of this scholarship are not eligible to apply.

Selection Process

1. Completed Application Form

2. Finalists will be selected based on the following criteria:

a) Academic and Degree Progress Pre-Requisites

- i. Maintain a minimum GPA of 2.7 throughout the duration of the scholarship
- ii. Completed a minimum level of 2 full-time study periods (8 subjects)
- iii. Successfully completed WIL200, AND
- iv. Have adequate tuition fees remaining in your degree to apply the scholarship credit for this specific scholarship.

Essay Submission (Minimum 500 words)

Address the following questions within a 500 word (minimum) essay:

- Why are you the most suitable student to be awarded this scholarship?
- What could you bring to Motti + Smith Events?
- Where do you hope to be five years from graduating? How will your ICMS education and work experience within Motti + Smith Events contribute to this?



b) Industry Training Report and CV

If you have completed any or all of your industry training placement, please submit a copy of your industry training report outlining performance. Please include a copy of your most up to date CV.

c) Community, Leadership and Student Body Contributions

Community contributions form a vital part of your application. Include relevant information, for example, student representative council, community volunteering, and others.

3. Interview Stage

Students who are successful with their essay submission will progress to the interview stage. The interview will be conducted by the ICMS Scholarship Board including a representative from Motti + Smith Events.

Students who reach this stage will be contacted and notified of interview dates and times.

4. Announcement

Only finalists will be notified of the results by letter and email.

NOTE: Scholarship submissions will **not be returned**. Unsuccessful applications are not retained and will be securely destroyed.

Acceptance Procedure

Upon notification of being awarded the Motti + Smith Events Scholarship, the successful candidate is required to inform the College of acceptance or non-acceptance, in writing, within two working days of receipt of notification.



Terms & Conditions (please read carefully before signing the declaration)

- 1. The recipient of the Motti + Smith Events Scholarship agrees to abide by all prescribed rules and regulations of ICMS.
- 2. The recipient must have completed in full a minimum of two academic study periods (8 subjects) including the successful completion of WIL200 in order to attend the WIL placement and is required to maintain a minimum cumulative GPA of 2.7 prior to and during the tenure of the scholarship, and have adequate tuition fees remaining in your degree to apply the scholarship credit for this specific scholarship.
- 3. The Motti + Smith Events Scholarship is not refundable and non-transferable, meaning the scholarship cannot be converted to another program, education provider, or recipient nominated by the original recipient.
- 4. The Motti + Smith Events Scholarship or carried over credits are unable to be extended and should the recipient decide to cease the scholarship prior to completion then the total cost of all subjects undertaken (as at the cease date) must be refunded in full.
- 5. Once the successful recipient has been notified of the scholarship value, that value is not negotiable and not changeable.
- 6. Partial Scholarships are likely to be awarded when application numbers are high.
- 7. Subject to approval by the ICMS Scholarship Board.
- 8. Previous scholarship recipients cannot have existing scholarship credit remaining as at the commencement of the term they are applying for.
- 9. If the recipient's scholarship involves a work placement and a tuition credit component, the tuition credit will apply to the next term of study. At no time will any scholarship credit apply to fees already paid.
- 10. The Motti + Smith Events Scholarship may not be deferred.
- 11. Scholarship students are expected to maintain good to excellent overall professional conduct and act as ambassadors of the College at all times. Failure to do so may result in withdrawal or termination of the scholarship.
- 12. Motti + Smith Events reserves the right to terminate the scholarship should the scholarship student not meet a desired level of performance and/or professional conduct during internship hours.
- 13. Termination of the scholarship by either ICMS or Motti + Smith Events will result in cessation of any allowance and tuition fee waiver awarded to the recipient.
- 14. If the recipient of the Motti + Smith Events Scholarship is required to re-sit a degree subject, for whatever reason, he/she will be required to pay for that subject.
- 15. The recipient will be required to complete the necessary academic requirements while on placement as outlined the Work Integrated Learning Guidelines.
- 16. The Scholarship recipient is required to allow the ICMS Marketing Department to take his/her photo and write a student profile about him/her for publications and website use. The recipient must also have a willingness to participate in future marketing activities.
- 17. The scholarship recipient is required to be available to participate in representing ICMS at various events for example Career Expo's, Open Days, Orientation Weeks, etc.
- 18. The scholarship recipient will be required to complete an internship at Motti + Smith Events. This internship may involve a variety of activities including (but not limited to) event development and planning, dealing with contractors, volunteers, and suppliers, risk and safety management, liaising with security companies and dealing with statutory agencies. The student will receive a weekly amount set by this scholarship.
- 19. It is suggested where possible scholarship recipients complete a number* of contribution hours each study period that the scholarship is awarded.



- 20. The Scholarship recipients must be 18 years of age within six months of commencing the ICMS Bachelor degree.
- 21. College fees are subject to change.
- 22. ICMS or Motti + Smith Events decision is final and reserves the right to terminate the Scholarship at any time for poor academic performance (see above), professional conduct, inappropriate conduct (see ICMS Student Handbook) or failure to meet the requirements of Motti + Smith Events. In some cases, ICMS may deem that payment of tuition must be reimbursed by the student.
- 23. Academic Integrity: Academic misconduct will be reviewed from time to time. Any academic misconduct can inhibit your scholarship. Should your academic misconduct be registered as level 2 or 3 during your applicable scholarship, the scholarship credit will be immediately discontinued.
